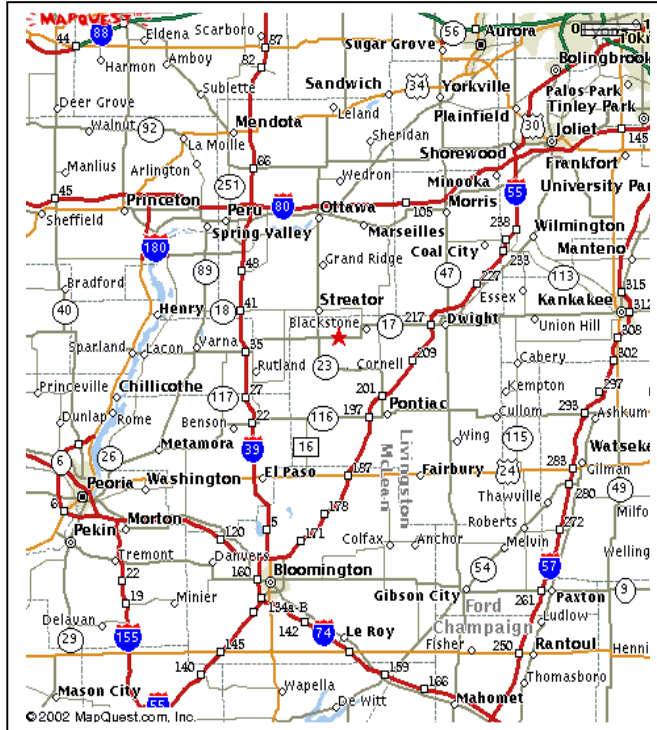


DIRECTIONS TO TRIAL SITE

All entries must be submitted on an **OFFICIAL UNITED KENNEL CLUB ENTRY FORM** with agreement on back.

Entries will not be accepted without signature, fees and Official entry forms. No refunds after closing date or limit is reached except bitches in season. Veterinarian statement must accompany request.

**Rosette will be awarded for High in Trial. Flat ribbons will be awarded for first through fourth places in each division. No awards will be mailed.
**These trials are open to dogs at least twelve (12) months of age registered with the United Kennel Club.
** No bitches in season allowed on the premises.
** The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the UKC rules and regulations of this sport. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such cases, no refund of any fees paid will be made.
** Please keep the show site clean by picking up after your dogs. Anyone not cleaning up after their dogs will be excused without refund of any entry fees.
** Off-Leash controlled exercise area and pond in back area of property, exercise at your own risk.
